NEWER RV!!

We were able to purchase a 23 foot, Ford Conquest 2000 RV with the proceeds from the Benefit Banquet and with a generous donation from an anonymous donor. With the help of David Ostrowski, we were able to reconfigure the inside of the RV to include a medical examination table. The newer RV is such a blessing, easier to drive and park, which is important as we travel to new venues. Currently, we are going to the Falls Church Healthcare abortion clinic on Wednesdays and Saturdays, usually from 7:00am-12:00pm. Dr. Kirsten Ball performs the ultrasounds for the women who come to us, and so far, we have given almost 70 ultrasounds. We would like to be operational five days a week and are searching for an experience, pro-life ultrasonographer to help us on the other days. Our goal is to raise \$30,000 to provide A Best Choice with an additional ultrasonographer.



We have made repairs to the original, older RV so that it passed inspection, and hope to be on the road with it as we grow with more staff and another ultrasound. When it didn't pass inspection and wasn't drivable, we met girls, mostly from Woodbridge and Manassas, at our stationary location off of Route 234 in Manassas.

Virginia Beach Sidewalk Counselor to Start a Pro-Life Mobile Ultrasound Ministry!

The Knights of Columbus have been wonderful! In addition to fundraising for an ultrasound for us, they have given us funds for operation and for an IPAD in order to sidewalk counsel women near abortion clinics. A sidewalk counselor who I visited in Virginia Beach uses the IPAD for this purpose. The day I visited her, there were 27 cars in the parking lot of the Planned Parenthood abortion facility. She visited us in Falls Church to familiarize herself with mobile ultrasound and was so inspired by our mission, that she is seeking an RV and ultrasound to start a prolife mobile ultrasound ministry close to this busy Planned Parenthood in Virginia Beach.

Students for Life at George Mason University

The Students for Life group at George Mason University, which we helped to establish, invited Serrin Foster, President of Feminists for Life, on campus and gave a wonderful history of the feminists throughout history who were advocates for women and the unborn.

John Murray, Anna Maher (President of Students for Life), and others are working on a presentation called, "What to Do When a Friend Says She's Pregnant". In the presentation, we discuss the dangers of abortion and offer resources to women facing unplanned pregnancies. We hope to introduce this presentation at George Mason University and to church youth groups. John has also put together a folder with several brochures on abortion alternatives and resources for women in unplanned pregnancies, along with a model of a 12 week unborn baby on the front, which has been received very well by the pregnant women that we sidewalk counsel and those we give ultrasounds to.

Saved Babies!

Our first saved baby, Jayden, just celebrated his first birthday on April 1st! Please see our website for the whole story at www.abestchoice1.org.

(Names have been changed in the story to keep client confidentiality.) Another saved baby, John, is now six months! On March 8, 2013, his mother, Sheri, was intercepted by Ruby Nicdao, a sidewalk counselor and head of Lifeguard, at the Eaton Place abortion facility in Fairfax, Virginia. Sheri was only two weeks along, too early to terminate her pregnancy, so the abortion facility told her to come back in a few weeks.

Ruby called Sheri during the following week and Sheri mentioned she would be going back to Eaton to schedule an ultrasound on Friday. Ruby asked her if she would be open to a free ultrasound. Sheri agreed and scheduled an ultrasound with us for Thursday, May 14th.

On Thursday, May 14th after four hours of negotiations, encouragement, and prayers, Sheri finally agreed to have the ultrasound with us. She came at 11:00 pm from Richmond, and we counseled her until 2:00am. She said she needed \$20,000 since her boyfriend lost his job and with no insurance she was concerned this newborn would need special intensive care after birth like her first baby. However, she decided that night she would have the baby and was very thankful! It was a great joint effort with the help of Mark Hall of Messengers of Hope, Ruby Nicdao of Lifeguard, and Dr. Kirsten Ball and Angela Clark of A Best Choice Mobile Ultrasound. John was born in November!

A month ago, we gave an ultrasound to a very young woman, Julie. Her boyfriend wanted her to have an abortion. We counseled her and Dr. Ball performed the ultrasound and informed her that she was carrying twins. You could see them very clearly on the screen and they were very active. At that point, the young woman started crying and got very emotional. The next day, I called to see how she was doing, and she said that after speaking with her boyfriend, and informing him that they were expecting twins, he had a change of heart and they decided to keep the babies. I spoke to Julie last week, and she found out that she is carrying twin boys!

A couple months ago, we sidewalk counseled a couple going into the abortion clinic for a pregnancy test. I was able to intercept them and offer them a free pregnancy test on the RV and counsel them. After speaking life over them, it didn't appear as if they had made a firm decision when they left. However, thirty minutes later, I received a call from the pregnant woman, telling me that they had changed their mind and are going to keep the baby!
